<p>Private markets investments continue to grow across retail, sophisticated and institutional investor portfolios. Better portfolio diversification and enhanced returns are two of the main benefits that investors gain from investing in private markets and key drivers of this momentum.</p> <p>Investments in private markets have outperformed traditional asset classes, such as equities, debt and cash, over sustained periods of time, as good investment managers can make proprietary investments and work actively towards building the value of these investments. The diversification provided by private markets investments in a portfolio can provide a buffer to returns when traditional asset classes such as listed equities underperform, and they also provide exposure to sectors that are underweight in listed markets.</p>

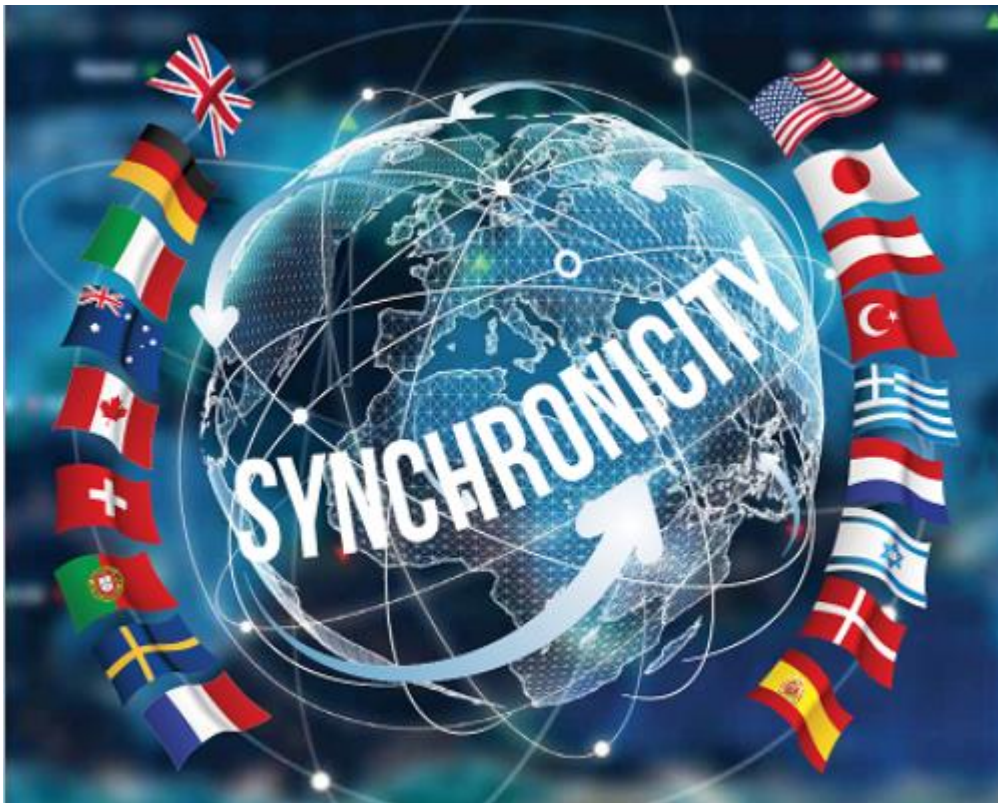
